## Health Insurance Marketplace Benefits for Women

Women have new rights and protections in the Health Insurance Marketplace starting in 2014. Marketplace highlights for women include: you won't be charged more for health insurance just because you're a woman; you can't be denied coverage or charged more due to pre-existing conditions, like cancer or being pregnant; you can choose from any primary care provider, OB-GYN, or pediatrician in your health plan's network without a referral; and you'll get free preventive care like mammograms, well-woman visits, breastfeeding support, and more. Open enrollment began Tuesday, October 1 and coverage begins January 1, 2014.

## USBC Awarded New Funding from CDC

USBC has been awarded funding from the Centers for Disease Control and Prevention (CDC) under its new program, National Innovative Partnership for Addressing Obesity through Environmental Supports for Nutrition and Physical Activity. Through this three-year cooperative agreement, USBC will be focusing on two program strategies:

- Provide access to professional and peer support for breastfeeding. USBC will collaborate with key organizations active in increasing access to professional and peer support for breastfeeding, and create resources and communication mechanisms to facilitate work in this area.
- Promote and facilitate worksite compliance with Federal and appropriate State lactation accommodation laws. USBC will also train, track, and promote a cadre of worksite support advisors available to support employers with implementation of lactation accommodations.

Response to Online Milk Sharing Study

A new study published in the journal Pediatrics found that breast milk purchased online had more bacteria and viruses than unpasteurized samples of milk donated to a milk bank, reflecting poor collection, storage, or shipping practices. Responding to extensive media coverage on the study, the Academy of Breastfeeding Medicine published the blog post, "Online milk sales, beyond 'buyer beware'", analyzing the study design and news coverage and offering recommendations. AAP News, the official newsmagazine of the American Academy of Pediatrics, published the article "Breast milk is best from mom or milk bank, not bought online", highlighting the study and related recommendations from national health authorities. ## Breast Pump Insurance Resource

While the Affordable Care Act (ACA) has expanded benefits for breastfeeding by requiring most health insurance companies to cover the full cost of a high-quality breast pump without co-pays or deductibles, coverage does vary among insurance plans. ## Revised Clinical Protocol, from ABM

The Academy of Breastfeeding Medicine has published a revised Clinical Protocol \#17: Guidelines for Breastfeeding Infants with Cleft Lip, Cleft Palate, or Cleft Lip and Palate, presenting ten recommendations for clinical practice. Recommendations include immediate access to a lactation specialist for mothers who wish to breastfeed, modifications to breastfeeding positions, and guidelines on breastfeeding following cleft lip/palate repair.

## Fourth Edition Self-Study Module, from Wellstart International

Wellstart International has published the Fourth Edition of the Lactation Management Self-Study Modules, Level 1. This basic tool is designed for medical and nursing students and anyone who has not been exposed to this information previously. It is accepted by Baby-Friendly USA to meet the requirement of three hours of training for physicians as well as partially meeting the requirement of 20 hours of training for nurses.
